# USA

The U.S. is a country of 50 states covering a vast swath of North America, with Alaska in the northwest and Hawaii extending the nation's presence into the Pacific Ocean. Major Atlantic Coast cities are New York, a global finance and culture center, and capital Washington, DC.

Washington, DC, the U.S. capital, is a compact city on the Potomac River, bordering the states of Maryland and Virginia. The official language is English and the currency USD.

## **Bilateral Trade**

**Goods Trade**: Starting from a modest \$ 14 Billion in 2000, the bilateral trade in goods has increased to \$66.3 Billion in 2015 (CAGR of 11%), making U.S. our second largest trading partner. Of this, India exported \$44.8 Billion to US and imported \$21.5 Billion from US. Trade in goods during Jan. - Sept. 2016 was \$49.9 Billion as compared to \$51.1 Billion during Jan.-Sept. 2015; which is a 2.4% drop.

**Trade in Services:** Bilateral trade in services grew at a very fast pace since the year 2000, increasing from a mere \$6 Billion in 2000 to \$42.8 Billion in the year 2015 (CAGR of 14%). Of \$42.8 Billion in 2015, India's exports of services to the U.S. were valued at \$24.7 Billion and India's imports of services from US were valued at \$18.1 Billion.
