Sub: Formation and Jurisdiction of Commissionerate of Service Tax VI -reg

The Trade Notice No. 54/2014 dated 08.10.2014 issued under F.No.V/ST-II/Tech/05/2013 is amended as under:

- 2. In terms of Notification No. 1/2015-SERVICE TAX dated 20.01.2015 the existing Service Tax VI Commissionerate shall consist of the following areas of the Municipal Corporation of Greater Mumbai -
 - Ward of K (West),
 - Ward of P (South),
 - Ward of P (North),
 - Ward of R (South),
 - Ward of R (Central),
 - Ward of R (North) &
 - Palghar District in the State of Maharashtra
- 3. The office of the Commissioner of Service Tax-VI, Mumbai shall be presently located at 1st Floor, Mahavir Jain Vidyalaya, C.D. Burfiwala Marg, Juhu Lane, Andheri (W), Mumbai 500 058.

- 4. The Commissionerate shall be divided into Eleven Divisions. Present Service Tax Registrants, whose declared premises for the purpose of obtaining Service Tax Registration located within the territorial jurisdiction mentioned above, shall come within the jurisdiction of the Commissionerate of Service Tax-VI, Mumbai.
- 5. The taxable person having Service Tax Registration within the jurisdiction of the Commissionerate shall come within the jurisdiction of individual Divisions of the Commissionerate as given below:
